Dear Mr. Thacher:

It certainly was nice to get your telegram yesterday telling me that the days suggested for Dumbarton seem to work in reasonably well with your plans. I hope, therefore, to arrive on the afternoon of Friday the 21st of November, and as I shallhave had a pretty stiff few days in New Haven and New York, perhaps we had better not make any engagements for that evening. Saturday seems to be free and I thought probably that day would be occupied mainly in catching up with the work of Miss Sweeney and Bryce, with perhaps a few snatches of your time. On Sunday afternoon I fear I may have to go to Alexandria to see some land belonging to Mrs. Leonard Elmhirst's son, but as Sunday is usually a busy time for you, you will not even notice my absence:

Monday I have suggested, as you will see by the enclosed two carbon copies of letters both to Mr. Drury and Mr. Root, that we meet at Dumbarton Caks in order to settle the question of the path across Clifton Hill. There is not really very much at stake but I should report to the Two in Santa Barbara as fully as possible in as many different directions.

If these suggestions do not fall in with your time, will you ask your secretary to make such cancellations as you think advisable. On Tuesday afternoon the 25th I should be heading westward in the 5:45 train, but I think the days in Washington will do such work as we have in hand without too much of a rush.

It was nice to hear from Bryce that Dumbarton Oaks is going full swing, and from you that its first birthday was a happy one. Thank you for your nice message to me.

I have written to Bryce to suggest that if the big oak in the green garden is taken out that we do either one of two things, replant the oak with a reasonably small tree (which is going to look like a match for years) as this is really the only safe size, or to leave the space empty, which is the plan to which I feel most inclined.

I am writing to Mr. Coles who seems to have been dawdling on the inscription for the outer wall of the exhibition room, the inscription of the 32nd street wall, and several odds and ends that should be tied up hefore I go west for the winter.

Thank you for all you have done for Miss Sweeney. Naturally I am trying to keep in touch with her as closely as possible, partly in order to take the major part of the responsibilities off your shoulders; and partly so as to have as complete a series of documents for the family inCalifornia as possible. The more we can limit her journeys to at most one a day the better it will be, and we ought to keep the time down to an hour or an hour and five minutes.

My Chief continues to improve but it goes to my heart to leave him next Monday as we have been so much and so closely together this summer, but you can easily see that I realize he is better, otherwise I should not be leaving.
