Don't think Mr. Thacher and I skimped on our Dumbarton time as two appointments were available for him but at the end of an hour and a half he said he had finished his business and theught another appointment unnecessary.

It is my very great hope that next spring we can get started on the remodelling of the herbaceous border as it has long seemed to me to need overhauling and if we can begin planting some of the shrubs which will make a hew background (and incidentally reduce the space which Bryce will have to plant with temporary displays) it would seem to Mr. Patterson, Mr. Thacher and me a wise proceeding. I hope with all my heart it will be possible to do away with the ragged yew hedges on the north and south sides of the border and possibly replace the yew hedges running north and south through the vegetable gardens with low walls, as we have long contemplated walls covered with the more delicate vines like Jasmine and Clematis which would be well displayed in this place and would be inexpensive to keep up and to plant.
