Thanks for the draft of the Van Rensselaer "Needs of the Botanic Garden". I will work this over and try a digest of it and will send it direct to Van Rensselaer unless it seems necessary to worry you to again look over it.

It's maddening to have to plan to come to Dumbarton just for the couple of days before you get home from your leave but these two days will be more than used up in the chores, measurements and working over arrangements with Bryce, and then I am hoping to come back again in October and will try and fit my dates to exactly marry in with yours. It now looks as though the best days for me would be to arrive sometime on Sunday October 29th and probably to leave again sometime on Tuesday the 31st. Let me know if these dates seem totally impossible for you. I have to remember of course that Mr. Thacher's freest days are Saturday and Sunday and therefore usually regulate my visits on this basis.

A particularly nice letter came from Mrs. Thorne speaking with enthusiasm and admiration for not only your gift to the Botanic Garden but also for the wisdom and foresight which have prompted it. Evidently she feels as I do that the Botanic Garden's future is now assured and that it has a very real important future. Mrs. Thorne further says that she stands ready to do anything in her power to see that what you hope for the Garden may be accomplished. This seems the end of my budget and I apologize for making it so long. Max and I are daily in the garden and he is so happy in being strong enough to do more work on the Franklin than he has been able to accomplish for over two years.
